\* Please Note: Prices below reflected before 6% sales tax. All memberships start the date of purchase and end one calendar year from date of purchase. Monthly payment options require first month paid in advance and then the reflected monthly price for the next seven months. Monthly memberships must be paid in full *no later than* seven months from date of purchase and require a valid credit card on file.

▶ **All-Inclusive Memberships:** Includes unlimited golf *with cart*, unlimited range privileges, 25% off apparel and 10% off equipment.

▶ **Standard Memberships:** Includes unlimited golf and unlimited range privileges but *does not include cart*. Cart fee is \$15 per player. Also includes 25% off apparel and 10% off equipment.

▶ **Seven Day:** Includes unlimited golf and unlimited range privileges all days of the week, including holidays.

▶ **Five Day:** Includes unlimited golf and unlimited range privileges, Monday-Friday, excluding holidays.

▶ **Junior Membership:** Includes unlimited golf and unlimited range privileges all days of the week, excluding holidays. Junior members must be under 18 years of age to qualify and are only eligible to use a cart (for an additional cart fee) if older than 16 with a valid driver's license. Also includes 25% off apparel and 10% off equipment.

▶ **Family Membership Upgrade:** Covers spouse/partner and up to two children under the age of 18. All covered individuals must cohabit with primary member.

**Additional Terms and Conditions:**

- ▶ **Ownership:** Memberships are non-transferable and non-refundable.
- ▶ **Registering:** All Members must register with the Pro Shop staff PRIOR to using the facilities. Memberships do not entitle Members unauthorized or unlimited access without the knowledge and consent of Pro Shop staff. Failure to comply may result in suspension or termination of all Golf privileges.
- ▶ **Golf Course Privileges:** Access to the golf course is subject to availability. Certain private events may dictate that the golf course, practice areas, grill and/or other areas of Houston Oaks Golf Course are closed. Member understands and agrees that nothing in this Agreement shall entitle Member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility, grill and other privileges/benefits may be limited by Houston Oaks Golf Course as necessary.
- ▶ **Golf Cars:** Use of golf cars is restricted to Houston Oaks Golf Course customers. Golf cars MUST be signed out prior to each use. Only licensed drivers may operate the golf cars. You must adhere to the rules and regulations, as set forth in the operation manual and/or all posted instructions.
- ▶ **Code of Conduct:** All Houston Oaks Golf Course Members, and their guests, agree to abide by the rules and regulations of Houston Oaks Golf Course. Any Members in violation of any rule or regulation of Houston Oaks Golf Course or for conduct which in the opinion of the management is detrimental to the welfare, safety and character of Houston Oaks Golf Course may be expelled by management.
- ▶ **Damage or Injury to Person or Property:** Member agrees to pay for any damages to the facilities or grounds, or for injuries to any person, caused by Member. Member also agrees to hold Houston Oaks Golf Course and its employees, agents, and owners harmless and to defend them against any and all claims, damages, and suits, for damages or injuries of any nature, whether to Member or to others, that may arise from or be related to Member's use of the golf course, its facilities or equipment.
- ▶ **Liquor Policy:** Houston Oaks Golf Course is responsible for all distribution of alcoholic beverages per Houston Oaks Golf Course's liquor license and KRS 243.020. No personal alcohol will be permitted on the premises.
- ▶ **Property and Equipment:** Houston Oaks Golf Course property includes equipment that is provided for our guests/Member's use. These items include, but are not limited to, range balls, range baskets, coolers, sand bottles, and other equipment provided. Removal of these items from Houston Oaks Golf Course property will be deemed as theft and violators will be prosecuted.
- ▶ **Fees and Charges:** Member understands and agrees that Member is responsible for payment of membership in its entirety. Member understands that all memberships are a 12-month commitment. All annual memberships and fees must be paid in full at the time of signing. All Members opting for a monthly payment option must pay membership in full within the first seven months, with the first month paid upon signing. Any discounted Member rates must be paid in full and may not be combined with any other promotional offers. Member understands and agrees that Member is responsible for all other charges incurred by Member at Houston Oaks Golf Course, including but not limited to charges for food and service at the grill or items purchased from the Pro Shop. Annual or monthly fee does not apply toward tournament play or special events.
- ▶ **Cancellation:** A breach of any of the terms and conditions of this contract will result in the cancellation of Member's rights and privileges without any reimbursement of any kind. Should Member wish to cancel this agreement prior to its stated expiration for any reason whatsoever, there will be no refund, partial or otherwise, on the fees paid by Member.

**PAYMENT OPTIONS: Cash, Check or Credit/Debit. All cards used for annual/monthly dues will incur a 5% transaction fee. For card payment, please fill out "Credit/Debit Card Authorization Form" on Page 3 of this Agreement.**
